UDH Helps Local Democratic Sweep

The areas worked by our United Democratic Headquarters showed clear evidence of the impact of volunteer efforts. Not only did Congressman Adam Schiff and Assemblyman Anthony Portantino shrug off aggressive Tea-Party-backed challengers, they did so with extraordinary victory margins.

Voters were not showing much inclination to split their tickets this year. At the top of the ticket, Brown and Boxer generally ran with a percentage point or two of one another. Schiff and Portantino ran very close to one another, too – and both ran several points higher than the statewide candidates.

We can't yet tell much about turnout, since the current figures do not include many thousands of late mail ballots, as well as provisional ballots cast on Election Day. Generally, though, turnout looks quite similar to four years ago – perhaps a few points higher in the UDH areas.

Drop-off rates were very low in the UDH area – much lower than usual – which means that the effort to get Democrats to vote all the way down the ticket paid off.

Proposition 19 might have passed if only local voters were consulted. Pasadena, Altadena, South Pasadena and NE Los Angeles all voted YES – and Sierra Madre was just barely NO.



Well, the people have spoken -- or at least some of them have. Those that did speak weren't too enthused about how we Democrats have performed. But few of the post-election commentators have talked about how many voters just didn't vote, and who those people are.

As an example, in Ohio, Democrats lost close Gubernatorial and Senate races. Out of 3.6 million votes cast, the margin in the Senate race was less than 100,000 votes. But in '08, in the Presidential race, over 5.6 million voters cast ballots -- which means 2 million voters stayed home. The turnout was dramatically lower than even 2006, when 4.2 million voters cast ballots.

The story is the same across the mid-west. In Pennsylvania, 4 million ballots were cast this year, compared to nearly 6 million in 2008. In Illinois, 3.5 million people voted this year, versus 5.5 million in 2008.

Why does this happen, and who are those lazy non-voters? Unfortunately, turnout in midterm elections has always been noticeably lower than in Presidential races. The drop-off is particularly pronounced among young voters (under 35); only about half of the young voters who vote in Presidential years vote in offyears. It's also particularly high among voters who have moved in the last year. On the other hand, drop-off among senior citizens is quite low -- nearly 90% of those who vote in Presidential years also vote in off-years.

Thus, the drop-off hits Democrats particularly hard, which helps explain why Democrats lost so many House seats. It's also worth remembering that many of those seats were in relatively conservative areas. In fact, of the seats still held by Democrats, only 12 are in Congressional Districts that President Obama lost in 2008. Conversely, 55 seats that were won by Republicans are in Districts that the President carried in 2008. So Democrats will have a broad array of ready-made targets for the 2012 election.

None of this, however, tells us why those voters chose to stay home, and why so many other voters -- independents and some Democrats -- clearly voted against the Democrats this year. For that, we rely on pollsters to try to tease out whether voters are asking for less taxes, lower deficits, or simply more jobs and less economic fear.

Unfortunately, there aren't really any clear answers. Pollsters from each side try to design polls to explore their own hypotheses. It does seem clear that people who were more worried about the economy tended to vote for Republicans, while those less worried about the economy tended to vote more Democratic. Further, Republican voters seemed more Page five

focused on cutting taxes and reducing the deficit, while Democratic voters seemed more willing to spend money to create jobs. That assumes that the federal government really can create jobs by spending money, or that cutting taxes and reducing the deficit will not lead us into a deeper recession by putting folks out of work.

One of the interesting outcomes of the election, though, is that we can now test all the different pollsters to see who is better at that arcane art, and who allows inherent biases to slip into their results. The web site Electoral-Vote.com looked at 9 different major polling companies, and compared their final poll in

each Senate contest with the outcomes. Then the web site averaged the results, looking to see how accurate the polling was overall, and if there was a consistent bias in each company's results. The Rasmussen organization, which was one of the most prolific and highly quoted polling groups, had the worst record: they were the least accurate, with an average error of 6%, and the most consistently

biased -- that is, their results gave, on average, a 4% edge to the Republican candidate. The Quinnipiac organization was one of the most accurate, with an average error of just 0.7% and a 2% bias toward Democratic candidates.

One can also look at individual states and ask, overall, how closely did all the pollsters come? In many cases, the final polls were well within the stated margin of error (typically 3 - 4%). A few states, however, stand out, where all the polls were consistently off in the same direction by large amounts. Nevada stands out in that group, where every polling group was 7 to 9% off, all predicting lower Democratic percentages. This may be an excellent

cautionary tale of the difficulty of predicting, and polling, Latino turnout. The exit polls showed Latino voters in Nevada not only turned out in record numbers, but voted nearly 90% for Sen. Harry Reid. In retrospect, that's hardly surprising, with Sharon Angle advocating an exceptionally hard line toward undocumented workers, and with the Arizona law prominently discussed in the media. But pollsters clearly underestimated the impact of Latino voting and were unable accurately to poll Latino voters, perhaps because pollsters typically are not fluent in Spanish, and Latino voters who are more comfortable speaking Spanish may be those most likely to vote

> Democratic. Whatever the reason, this simply reminds us that, over the long term, Republicans place themselves in peril as they continue to alienate Hispanic voters.

> Here in Pasadena, we are now ramping up for our local elections. Mayor Bill Bogaard, so far at least, has not drawn an identified opponent for another fouryear term as Mayor. Not so for Councilmembers Jacque Robin-

son and Steve Madison. Madison, from District 6, will be opposed by Carolyn Nabor, a well-known local anti-growth activist, who is also a very conservative Republican and is said to be the anointed Tea Party candidate in that District. It appears that her campaign is being run by Martin Truitt, a local Republican consultant who has run a number of other campaigns in past years. Word is that the Tea Party folks are committed to running candidates in each race, and Truitt may run several of their campaigns. The only Councilmember who has not drawn an opponent, so far, is Margaret McAusten.

Filing for both City Council and School Board candidates opens Monday, Nov. 15 and closes

Friday, December 10, with an extension to Wednesday, Dec. 15 for those races where the incumbent is not running for re-election.

One of those not running for re-election is School Board President Bob Harrison. That will leave his seat open, while colleagues Tom Selinske and Renatta Cooper are seeking another term. With the potential closure of at least two elementary schools, and recent teacher layoffs, those Board members might be facing a tough election. However, the latest state budget treated schools better than expected -- a feared reduction of \$250 per pupil in basic per pupil funding, and a further freeze in the Cost of Living Allowance, were not imposed, so PUSD is looking at an additional \$5 million in baseline funding for this year, and all future years. That's not to say, however, that the state won't be looking at further mid-vear cuts, because most observers believe the current budget is based on unrealistic income assumptions. So we're not out of woods vet, but at least there's a minor ray of hope on the horizon.



From State Senator Carol Liu...

November Update



Congratulations to UDH and all the Democratic candidates who successfully ran for election in 2010. Besides our local representatives, we now have a Democratic Governor and hopefully, a complete and more compassionate change of direction for our state. Voters also approved Prop. 25 enabling the legislature to pass a state budget by a majority vote. Hopefully this will result in a more humane budget without the devastating delay in payments to vendors and workers caused by prior budget stalemates.

In the wake of the election there are other changes afoot. On December 10, the Census Bureau will deliver its final apportionment counts based on the 2010 Census to President Obama. The data will be released to the public in March 2011. The national Census completion rate was 74% of households and California's was 73%.

The Constitution mandates the Census for purposes of Congressional apportionment, but Census data are also relied upon for federal funding formulas; federal, state, and local government planning; academic research; and even private-sector marketing. In California, these data will be used by the voter-approved Citizens Redistricting Commission to draw State Senate and Assembly district lines. Now, with the passage of Prop. 20, the Redistricting Commission also will be drawing Congressional district boundaries.

The State Auditor is continuing to select re-

districting commissioners. On November 15, the Senate President pro Tempore, the Assembly Speaker, and the minority party leaders of both houses submit their whittled-down lists of commission applicants. Each leader is allowed to strike two applicants from each of the three applicant pools – Republicans, Democrats and "Other" (DTS, Greens, Libertarians, etc). This will reduce the applicant pool for the initial lottery from 60 to 36.

Next, on November 18, the State Auditor will randomly draw eight candidates from the remaining applicant list. These eight applicants will make-up the first commissioners of the Citizens Redistricting Commission, and they must work together to hire staff and fill the remaining six seats on the Commission. On another front, thousands of California families were given a reprieve from losing their child care when a state judge temporarily blocked Governor Schwarzenegger's lineitem veto of CalWORKs Stage 3 child care funding. Alameda County Superior Court Judge Wynne Carvill ruled that before the funding is cut, affected parents need to be notified of child care alternatives for which they may be eligible.

Schwarzenegger blue-penciled the \$256 million in Stage 3 funding when he signed the 2010-11 state budget in early October, thus terminating subsidized childcare for about 60,000 low-income parents who have been off welfare for two years and are currently undergoing job training or working. Some 81,000 California children are affected, 17,000 in LA County alone. Parents represented by Parent Voices Oakland sued the state, claiming the cuts jeopardized their ability to work and that the state should have automatically enrolled eligible parents into other subsidized child care programs.

Prior to the judge's order, Democratic legislators encouraged local First5 Commissions throughout the state to provide bridge loans so childcare could continue until a bill to reinstate the funds can be enacted. Thirty-five First5 Commissions, including LA County, stepped up to the plate, but not all the funding needed is in place. A bill to restore the funds will be introduced on the first day of the new legislative session. December 6th with plans to pass it and send it to Governor Jerry Brown for signature in January. Fortunately, the judge's stay means the loans are not needed right away which allows them to stretch a bit further. The stay by Judge Carvill remains in effect at least until November 23, when another hearing on the lawsuit is scheduled.

A final note: please save the date for my

New Data: 3,370 Seniors in the 29th Congressional District Have Already Received Medicare Rx "Donut Hole" Checks

This year, all seniors who have drug expenses of \$2,830 or more – and thereby enter the Medicare Part D "donut hole" – will receive a \$250 rebate to help with their high drug costs. Beginning in January 2011, all seniors will receive a 50% discount on brand-name drugs in the donut hole, saving the average senior entering the donut hole over \$500 annually. By 2019, the Part D drug donut hole will be completely closed.

In the 29th Congressional District of California, thousands of Medicare enrollees are already benefiting from the new law. As of Oct. 1, 3,370 seniors in the district received \$250 rebate checks, totaling \$842,500 to help pay their high drug costs. An additional 4,930 seniors are expected to enter the Part D donut hole before the end of this year; each of these seniors will also receive a \$250 rebate. By the end of the year, 8,300 seniors in the district will have received assistance to help cover the cost of their drugs, providing a total of \$2.1 million in assistance to seniors in the district. Donut hole benefits will increase beginning in January '11, when all seniors who hit the donut hole receive a 50% discount on brand-name drugs, saving seniors in the district \$4.4 million next year.

Schiff Applauds Efforts to Keep College Affordable

On average, college graduates earn \$1.3 million more over their lifetimes than those without a degree. With the unemployment rate almost twice as high for high school graduates as it is for college graduates, it is critically important to keep college accessible.

The College Board's recent "Trends in College Pricing" and "Trends in Student Aid" reports show that efforts to keep college affordable are more critical now than ever. While tuition and room & board expenses have risen for all categories of colleges and universities, student aid is up sharply. Pell Grants alone rose by \$10 billion to \$28 billion in 2009-2010. I supported the American Opportunity Tax Credit, which has helped even more students. The Treasury Department says 12.5 million

students and their families were provided with higher education tax benefits in 2009.

Thank You Nancy

Of all the politicians (Dianne Feinstein, Phil and John Burton, Barbara Boxer, Willie Brown, and Harvey Milk) I got to know in San Francisco the most gracious, genuine and humble was Nancy Pelosi. Nearly three years after he was appointed to investigate the destruction of at least 92 interrogation videotapes, a dozen of which showed two high-value detainees being subjected to various torture techniques by CIA interrogators, Special Prosecutor John Durham has determined that he does not have enough evidence to secure an indictment against anyone responsible for the purge.

The statute of limitations for bringing criminal charges ran out Monday.
